Privacy Notice for Third Parties

Under data protection law, individuals have a right to be informed about how the school uses any personal data that we hold about them. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

Privacy notice – how the school uses information from third parties

What categories of information are processed?

The categories of personal information that we process include the following:

- Personal information – e.g. name of organisation/individual, contact information, address
- Contract information – e.g. position, roles, salary information
- Qualifications, where relevant
- Safeguarding information – e.g. safeguarding checks

This list is not exhaustive – to access the current list of information the school processes, please see the school's Data Asset Register which can be found in the school office.

Why do we collect and use your information?

We collect and use your information for the following reasons:

- To improve the management of third-party data
- To enable the development of a comprehensive picture of the third parties used by the school and how they are deployed
- To inform the development of contacts and retention policies
- To allow better internal financial modelling and planning
- To allow individuals/organisations to be paid
- To manage the services that we deliver

The GDPR, the legal basis/bases we rely on for processing personal information for general purposes are:

- For the purpose of allowing individuals/organisations to be paid, in accordance with the lawful basis of contract (article 6 of the UK GDPR).

For special category data, we also rely on the following conditions under Article 9 of the UK GDPR:

- For the purposes of safeguarding children on site.

The legal basis is also in line with the statutory requirements for schools contained in the government document, Keeping Children Safe in Education

How do we collect your information?

We collect your personal information via the following methods:

- Contracts and enquiry forms
- Employment forms

Data relating to third parties is essential for the school's operational use. Whilst most of the information you provide us is mandatory, some of it is requested on a voluntary basis. To comply with the UK GDPR, we will inform you at the point of collection whether you are required to provide certain information to us or if you have a choice.

How do we store your information?

Your personal information is retained in line with the school's Records Management Policy, which can be found on our school website (www.berkswichceprimary.co.uk).

For more information about how we securely store your information, please see the school's Data Protection Policy and Data and Cyber-security Breach Prevention and Management Plan.

Who do we share your information with and why?

We do not share information about you with anyone without your consent, unless the law and our policies allow us to do so.

Where it is legally required or necessary, we may share your information with the following:

- The DfE – to meet obligations about supplying information regarding the school workforce, in accordance with the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

Any information we share with other parties is transferred securely and held by the other organisation in line with their data security policies.

What are your rights?

You have specific rights to the processing of your data, these are the right to:

- Request access to the information the school holds about you.
- Restrict the school's processing of your personal data, i.e. permitting its storage but no further processing.
- Object to direct marketing (including profiling) and processing for the purposes of scientific/historical research and statistics.
- Have your personal data rectified if it is inaccurate or incomplete.

- Not be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect on you.
- Request the deletion or removal of personal data where there is no compelling reason for the continued processing.

If you want to request access to the personal information we hold about you, please contact the school's Data Protection Office (DPO). See contact details below.

If you are concerned about the way we are collecting or using your information, please raise your concern with the school's DPO in the first instance. You can also contact the ICO at <https://ico.org.uk/concerns/>.

How to withdraw consent and lodge complaints

Where our school processes your personal data with your consent, you have the right to withdraw your consent at any time.

If you change your mind or are unhappy with how our school uses your personal data, you should let us know by contacting the school's DPO (see contact details below).

Updating this privacy notice

We may need to update this privacy notice periodically if we change how we collect and process data. We recommend that you revisit this privacy notice periodically.
